\* Section 2.3 Classification of Members and Voting Rights

a) There shall be two (2) classes of Membership with the following voting rights:

1. Class 1 (Members): One (1) authorized representative of business owners, building owners, and/or operators of businesses, not-for-profits and organizations in the Bagg's Square Area.
